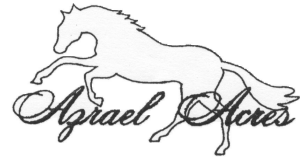

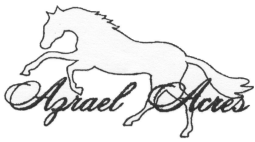

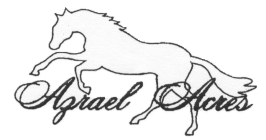
RULES:

- Jumping portion of 2-Phase will be a combination of Stadium Jumps and Cross Country Obstacles.
- Approved headgear required at all time when riding. Safety vests required when jumping. Appropriate show attire required for Dressage Tests. Half Chaps and Paddock boots will be allowed for all riders.
- Refunds will only be given to riders who cancel before closing date and slot can be filled from a wait list. NO refunds after closing date will be given. Closing date is 8 days before event; entries must be postmarked by then

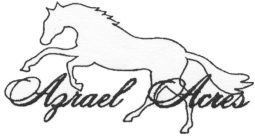

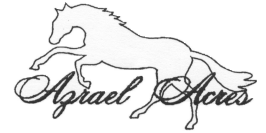
